## Agenda 1: Publication of research papers in SCI/SCOPUS/NAAS..... listed journals.

Resolution: All HODs/Representatives gave number of research publications from their Depts. for the year:2017-18 and also in the last 5 years. It is noted that publication in SCI/SCOPUS/NAAS...... listed journals has a good growth. The detail list will be publish after all HODs give output from their department.

## Agenda 2: Sponsored Research Projects

Resolution: It is noted that External Funding was received for 3 projects in academic year 2017-18. Currently in 2018-19 there is one sponsored project on-going. Applications are sent to AICTE for funds for 14 Projects last year for which decision is pending. One FIST project from the Institute and another R&D project from CSF dept. are submitted to DST. Recently 3 applications are sent for R&D funding from WBS&T. It is instructed to all HODs that each department has to try hard for getting funded projects. Each department is asked to apply for funding for at least 2 projects from IE(1) and also FDP from ISTE. More details of the project funding will be provided by Registrar (Acting). The last date for applying for FDP from ISTE is 20.10.2019.

Resolution: It is suggested that Sister concerns within JIS Group (e.g. Hash Technologies, Northern Cargo Services, etc.) are to be approached for getting consultancies.

## Agenda 4: Any other issues related to NIRF/NAAC
